



School Self-Evaluation and School Improvement Plan: Bí Cineálta

1. School Context:

Ennis National School is a large, inclusive primary school committed to fostering a safe, respectful environment. The school's existing commitment to well-being, evidenced by the implementation of the National Wellbeing Strategy and other initiatives, aligns perfectly with the Bí Cineálta policy's goals. Adopting the Bí Cineálta procedures demonstrates the school's dedication to ensuring all members of the school community feel safe, supported, and valued. Our school's core values of respect, kindness, and inclusivity are central to our approach to implementing Bí Cineálta.

2. Rationale:

Bullying significantly impacts pupils' well-being, academic success, and social development. A proactive, systemic approach is crucial to address bullying and uphold children's rights, as enshrined in the United Nations Convention on the Rights of the Child. The Bí Cineálta policy framework aligns seamlessly with Ennis National School's ethos and its unwavering dedication to fostering a culture of respect, inclusion, and kindness within our school community. This School Improvement Plan will ensure consistent implementation of the Bí Cineálta procedures and strengthen our capacity to prevent and address bullying effectively.

3. Key Findings Informing this SIP:

- **Inconsistent Bullying Response:** Analysis of bullying incident reports from the previous year revealed inconsistencies in how incidents were addressed across different classrooms. Contributing factors included variations in teacher training, understanding of the policy, and confidence in implementing the procedures.
- **Need for Clear Procedures:** Feedback from staff, parents, and pupils highlighted the need for clear, user-friendly procedures and consistent implementation of the BÍ Cineálta policy.
- **Preventative Measures:** Feedback emphasised the importance of preventative strategies, including proactive awareness-raising programs and peer-support initiatives.
- **Addressing Bullying Incidents:** Established procedures for investigating and addressing bullying incidents, including record-keeping. There is scope for improving consistency in recording of bullying incidents and alleged bullying incidents.

- **Annual Reviews:** The Anti-Bullying Coordinator and Principal will conduct a comprehensive annual review of the Bí Cineálta implementation, analysing data, gathering feedback from all stakeholders, and updating the SIP for the following year.

6. Projected Outcomes:

- Significant reduction in bullying incidents, resulting in a safer, more inclusive school environment.
- Increased confidence and competence among staff, pupils, and parents in addressing and preventing bullying.
- A sustainable, data-driven framework for fostering respect, kindness, and inclusivity within the school community.
