

School Self-Evaluation and School Improvement Plan: SET and SEN

January 2023 - June 2024 Ennis National School

The Department of Education carried out an inspection in Ennis National School in November 2022 which focused on Special Education Needs. Arising from the Inspection Report, the following Improvement Plan incorporating the official report and feedback from the oral meeting with the inspectors was compiled with a timeframe from January 2023 - June 2024. This plan prioritises the areas highlighted as needing attention, builds on existing strengths, and aligns with the Department's guidelines and recommendations. The plan was compiled following consultations with the school staff and Board of Management.

1. Introduction:

This plan builds upon the previous plan, incorporating feedback from the oral feedback meeting with inspectors and focusing on areas needing improvement while celebrating existing strengths. The timeframe is January 2023 - June 2024. The plan aligns with the School Self-Evaluation (SSE) framework and emphasises collaborative planning and ongoing monitoring.

2. Key Findings and Recommendations:

- **High Commendations:** Respectful learning environment, visual environment quality, pupil speaking and listening skills, quality of work, inclusion of ASD pupils in mainstream, Reading Recovery practices, sharing of staff expertise.
- Areas for Improvement:
 - **Consistency of SEN Teaching Practices:** Standardise SEN teaching methods across the school.
 - **Target Setting:** Implement SMART targets and consistently monitor progress, celebrating successes. Clearly define what pupils should achieve in each intervention.
 - Curricular Provision (Invention Classes): Extend curricular provision in Invention Classes to include SESE.
 - CPD for SETs: SETs to pursue postgraduate courses in SEN; SETs to engage in ongoing professional development.
 - **Support Provision Models:** Review support models; reduce withdrawal; justify rationale for one-to-one support, especially for high-achieving pupils.
 - **Classroom Support Plans:** Aim for 4-5 pupils per class to have a Classroom Support Plan; consult with parents.
 - Student Support Files: Improve accessibility of student support files.
 - Formal Meetings (Principal/SNAs): Implement regular formal meetings between the principal and SNAs.
 - Weekly SET Planning: Implement weekly planning for SETs as per Department guidelines.

- Monthly Reviews: Brief review of progress with SEN co-ordinator and principal.
- **Termly Reviews:** More detailed review of progress against the action plan.
- Data Analysis: Track pupil progress data regularly.
- Teacher and Parent Feedback: Meetings with parents to agree and sign each Pupil Support Plan
- Annual SSE: This action plan will be a significant part of the annual school self-evaluation.

5. Resources:

Resources (training budget, time for collaboration, administrative support) will be allocated to support this plan's implementation. The school will prioritise the allocation of resources to support the most significant areas of improvement.

This plan is dynamic; it will be reviewed and adapted at the end of each term based on progress and new information. The focus is on creating the best possible learning environment for all children at Ennis NS.
